1. We acknowledge the comments provided by Newco that were included in the WCMI letter as part of this submittal. The first two initial comments were in regard to comments 2. 6) and 2. 7) from the initial shop submittal response letter dated May 3, 2012.

As noted in the original shop submittal response letter, we request the supplier/manufacturer coordinate with WCMI and the metal building manufacturer on the door frame and framing to be accomplished at the openings where 4" head and jambs are specified and the framed walls are 4", 6" and 8" walls. *Make Corrections Noted*

- There was question whether the Schlage Rhodes lever handle could be used in lieu of the Schlage Sparta lever handle. We take no exception to the use of the Schlage Rhodes lever handle. No Exception Taken
- 3. In review of the hardware sets proposed for each door, please reference the Finish Hardware Schedule as detailed on Addendum No. Six (6). This shop submittal review will not include a detailed accounting of each part and piece to be utilized on each door. A prior submittal review of the doors included a review of the proposed parts and pieces to be incorporated into the project. This review includes verification that each door tag has been equipped with the

hardware set that is detailed in Addendum No. Six (6). In addition, the handing of the door has been verified and the window lite to be installed in the door has been verified.
